## <u>Questions and the College responses from vendors for the RFP#25-02 Charter Bus Services for</u> <u>Athletics</u>

- 1) In case of vehicle breakdowns, can we farm out?
  - a. Yes, as long as there are no additional costs
- 2) Can we split buses to accommodate passenger counts in case of vehicle malfunctions?
  - a. Yes, as long as there are no additional costs
- 3) Rfp mentions a penalty after 15 minutes late, is this taken off of the trip itself, or is it billed to us?
  - a. It can be taken off the trip invoice
- 4) Should be percent year two and three or do we just add the percent it will go up.
  - a. You can add the percentage it will go up by for each year
- 5) Is your cancellation policy negotiable? and if so what would be the terms.

- 6) Are you accepting bids for charter services to be performed by school buses that can meet the size specifications?
