## 2025-26 Unusual Circumstance

### What is an unusual circumstance?

An unusual circumstance occurs when a financial aid administrator exercises professional judgment and overrides the Department of Education's criteria for dependent students. An override may only be granted on a case-by-case basis for students with unusual and exceptional circumstances. These circumstances must show compelling reasons for a student to be considered independent rather than dependent.

### What conditions **DO NOT** warrant an unusual circumstance?

By Federal Law, the following conditions **DO NOT** warrant a usual circumstance

- Parents refuse to provide information on the Free Application for Federal Student Aid (FAFSA) application or for verification
- Parents do not claim student as a dependent for income tax purposes
- Parents unwilling or unable to contribute to student's education
- Student demonstrates self-sufficiency

When completing the 2025-2026 Free Application for Federal Student Aid (FAFSA), you answered YES to "Do unusual circumstances prevent the student from contacting their parents or would contacting their parents pose a risk to the student?" **We understand the sensitive nature of these circumstances; all documentation received by our office will be kept confidential.**

Check the unusual circumstance that applies and submit the required documentation:

- Abusive family environment (e.g., sexual, physical or mental abuse or other forms of domestic violence)**

#### **Required Documentation**

- Personal Statement by Student explaining your situation. Include your name, student ID number, date and signature.
- Personal Statement from a public official (*on letterhead*) who has knowledge of your unusual circumstance (e.g., *teacher, high school guidance counselor, member of clergy, law enforcement representative, social worker, government agency, medical authority, or clerk of courts*).
- Personal notarized statement from an adult who has knowledge of your unusual circumstances.
- Additional Supporting Documentation such as *court documents, legal documents, or police reports*.

- Abandonment by parents**

#### **Required Documentation**

- Personal Statement by Student explaining your situation. Include your name, student ID number, date and signature.
- Personal Statement from a public official (*on letterhead*) who has knowledge of your unusual circumstance (e.g., *teacher, high school guidance counselor, member of clergy, law enforcement representative, social worker, government agency, medical authority, or clerk of courts*).
- Personal notarized statement from an adult who has knowledge of your unusual circumstances.

**Please complete both sides**

- Additional Supporting Documentation such as *court documents, legal documents, or police reports*.
- Refugee or asylee status and are separated from their parents, or parents are displaced in a foreign country**  
Required documentation:
  - Personal Statement by student explaining your situation. Include your name, student ID number, date and signature.
  - Additional Supporting Documentation: Original documentation showing status as Refugee or Asylum granted (I-94, I-94-A, or I-571 with proper endorsements). Copies of any relevant supporting documentation (*e.g., court documents, legal documents, or police reports*).
- Victim of Human trafficking**  
Required Documentation
  - Personal Statement by student explaining your situation. Include your name, student ID number, date and signature
  - Additional Supporting Documentation: An eligibility letter from Health and Human Services (HHS), a T-visa, or a copy of 1-797
- Incarceration or institutionalization by both parents**  
Required Documentation
  - Personal Statement by student explaining your situation. Include your name, student ID number, date and signature.
  - Additional Supporting Documentation: Official federal or state documentation that your parents or legal guardians are incarcerated.
- Unable to contact or locate parents**  
Required Documentation
  - Personal Statement by Student explaining your situation. Include your name, student ID number, date and signature.
  - Personal Statement from a public official (*on letterhead*) who has knowledge of your unusual circumstance (*e.g., teacher, high school guidance counselor, member of clergy, law enforcement representative, social worker, government agency, medical authority, or clerk of courts*).
  - Personal notarized statement from an adult who has knowledge of your unusual circumstances.
  - Additional Supporting Documentation such as *court documents, legal documents, or police reports*.

**What is next?**

Your form will be reviewed to determine if documentation is sufficient. If any additional information is required, you will be contacted via email. Please allow 2 to 3 weeks for a determination.
