Your 2025-2026 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called "verification." The law says that before awarding Federal Student Aid, the Financial Aid Office may ask you to confirm the information reported on your FAFSA. To verify you provided correct information, the Financial Aid Office will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. **You and at least one parent (if a dependent student) must complete and sign this worksheet, attach any required documents, and submit the form and other required documents.** We may ask for additional information. If you have questions about verification, contact us as soon as possible to avoid a delay in processing.
