Required Documentation:

- A signed letter on official letterhead from a director of a qualifying shelter or program certifying your status.

- Student's high school or school district homeless liaison or designee**

Required Documentation:

- A signed letter of official letterhead from a school district liaison certifying your status.

- Director or designee of a project supported by a federal TRIO or GEAR UP program grant.**

Required Documentation:

- A signed letter of official letterhead from a homelessness liaison certifying your status.

- Financial Aid Administrator**

Required Documentation:

- A signed letter on official letterhead from the Financial Aid Administrator certifying your status.

- NONE of these apply**

Required Documentation:

- Personal Statement by Student explaining your situation. Include your name, student ID number, date and signature.
- Personal Statement from a public official (*on letterhead*) who has knowledge of your unusual circumstance (*e.g., teacher, high school guidance counselor, member of clergy, law enforcement representative, social worker, government agency, medical authority, or clerk of courts*).
- Personal notarized statement from an adult who has knowledge of your unusual circumstances.
- Additional Supporting Documentation such as *court documents, legal documents, or police reports*.

- You must correct the information on your Free Application for Federal Student Aid (FAFSA) by providing parent(s) financial information. You and one parent must sign the FAFSA and submit it to the federal processor.

DEFINITIONS

Homeless – means lacking fixed, regular and adequate housing, which includes living in shelters, parks, motels, hotels, public spaces, camping grounds, cars, abandoned buildings, or temporarily living with other people because you have nowhere else to go. Also, if you are living in any of these situations and fleeing an abusive parent, you may be considered homeless even if your parent would otherwise provide a place to live.

Unaccompanied – means you are not living in the physical custody of your parent or guardian.

Youth – means you are 21 years of age or younger or still enrolled in high school as of the day you signed your FAFSA.
